## **Notice to Bidders:**

All tax certificate sale bidders must pre-register prior to the day of the Tax Certificate Sale at the Ste. Genevieve County Collector's Office, starting Monday, August 18, 2025. All bidders must be pre-registered no later than Friday, August 22, 2025, to participate in the sale. The Collector's office will not accept new registrations the morning of the Tax Sale. The Tax Sale Registration Affidavit is available online in the Collector's Real Estate section of the County website: https://www.stegencounty.org/collector, for those wishing to fill out the form in advance. The original ink document must be submitted to the Collector's office no later than Friday, August 22, 2025.

**Note:** The Supreme Court of Missouri has determined that Deeds of Trust, Mortgages and other Security Interests may not be extinguished by Tax Sales held pursuant to Chapter 140 RSMo, and instead may remain in full force and effect. The Ste. Genevieve County Collector shall, upon this sale, transfer only such interests as she, the Collector, possesses, and the Collector makes no warranties, guaranties, or other affirmations as to the title to be transferred by this sale.
